




The water cooler must be connected to the water supply using a dielectric coupling. The cooler is furnished with a non-metallic strainer which meets this requirement. The drain trap which is provided by the installer should also be plastic to completely isolate the cooler from the building plumbing system.

Pushing tube in before pulling it out helps to release tube





A = Recommended water supply location. Shut off valve (not furnished) to accept 3/8" O.D. unplated copper tube connect.

B = Recommended location for waste outlet 1-1/4" O.D. drain.

C = 1-1/4" Trap (not furnished).

D = Power cord 4 feet (1219mm) long.
E = Insure proper ventilation by maintaining 4" (102mm) (MIN.) clearance from cabinet louvers to wall.

F = To level unit, loosen screws to adjust base for contact with floor. Tighten screws after unit has been leveled.
